

YMCA OF BUCKS AND HUNTERDON COUNTIES STARTING 2022 STRONGER TOGETHER

This was a monumental year for our Y, and it all began with expanding our services, participants and geography. On April 1, 2022, Hunterdon County YMCA in New Jersey and YMCA of Bucks County in Pennsylvania officially came together to create one YMCA across the two counties, operating as one YMCA of Bucks and Hunterdon Counties.

YMCA of Bucks and Hunterdon Counties serves the community through its seven membership branches, seven child care centers and two outdoor camp properties. The Y also nurtures nearly 1,000 students and their families in 21 school age child care programs throughout 15 public school districts in Bucks and Hunterdon counties.

“Stronger Together means exactly that. Just as we leveraged the strengths of the three formerly independent YMCAs in Bucks County to better serve the community, so have we done with the combined YMCA communities across the Delaware River,” explained Zane Moore, president/CEO of YMCA of Bucks and Hunterdon Counties. **“The Hunterdon County YMCA brings its expertise and success as an exemplary provider of child care and camp to the larger organization, while the great staff and volunteers from the Bucks side expand our reach in health, wellness, and community impact throughout the newly combined areas of service.**

Getting Right to Work: As a first step in assessing the needs of the Hunterdon community and where the Y is needed most, the Y engaged an outside consultant to conduct an assessment of YMCA branches and properties. In 2023, the YMCA board will evaluate the results of a diligent community needs assessment and set a course for the future of the Y in Hunterdon County. We hosted a forum for community leaders on Tuesday, September 27, at Stanton Ridge Golf and Country Club in Whitehouse Station, NJ as part of our Hunterdon County community needs assessment.



SOCIAL RESPONSIBILITY

The Y is For Social Responsibility, giving back and providing support to our neighbors. Whether developing skills or emotional well-being, welcoming and connecting diverse populations, or advocating for healthier communities, the Y fosters the care and respect all people need and deserve. Through the Y, volunteers, donors, leaders and partners are empowering people and communities to be healthy, confident, connected and secure.

We marked the conclusion of the highly successful comprehensive For A Better Us campaign in 2022, which raised over \$30MM for an expansion of our Doylestown branch and Fairless Hills branch renovations, as well as support for vital YMCA Pathway and financial assistance programs. Y Pathway programs such as the Veterans Wellness Initiative and THRIVE Cancer Wellness, are free to participants. Y financial assistance provides the means for many families to participate in YMCA child care and camp, as well as membership and programs. In 2022, YMCA of Bucks and Hunterdon Counties provided over \$825,000 in financial support to those who would otherwise be unable to participate in care and wellness at the Y.

Cutting the Ribbon in Fairless Hills

On April 14, 2022 more than 350 volunteers, donors, elected officials, staff and members of the community celebrated the reopening of the fully renovated Fairless Hills branch during a ribbon-cutting ceremony. Speakers included many of our leadership donors.

The Y has been the fortunate recipient of a tremendous amount of public support due to the efforts of elected officials. 
Friends of YMCA of Bucks and Hunterdon Counties Golf Invitational

On October 31, more than 200 attendees participated in our annual golf outing at the Union League Golf Course at Torresdale on a beautiful and bright fall day. Golfers played a morning or afternoon round, and competed for prizes. Over **\$226,000 was raised and 100% of the proceeds support programs and services for low to moderate income families who have children in child care or summer camp.**



Comedy Night

We hosted our 30th Annual Comedy Night on Friday, November 18 at the Hunterdon Hills Playhouse in Hampton, New Jersey. With nearly 300 comedy fans in attendance, the event raised over **\$80,000 for the YMCA's financial assistance program.** The "Send a Kid to Camp" appeal raised funds to provide financial assistance for **113 children to attend YMCA day camps this summer.**

Cause Membership

In 2022, YMCA of Bucks and Hunterdon Counties unveiled the innovative Cause Membership. Growing from what we learned during the COVID-19 pandemic, we wanted to expand opportunities to connect with the Y mission without having to purchase a branch membership. With Cause, the Y provides members opportunities to connect and support the causes particular to their interests, all while contributing \$10 per month to support Pathway programs and Y financial assistance. Cause members receive frequent updates about their Y causes, opportunities to connect with other members and families, and free access to Y Wellness 24/7. Y Wellness 24/7 is an online wellness platform providing members with thousands of live and on-demand classes in fitness, mental health and nutrition. Cause membership continues to grow at YMCA of Bucks and Hunterdon Counties, with more benefits and opportunities coming in 2023!



Holiday Gift Card Drive

During October and November, we inspired the community to help families in the YMCA Financial Assistance program prepare for the holiday season. We asked members and the entire community for gift cards from large supermarkets and big box retailers to be dropped off at our welcome centers. Throughout November, gift cards were distributed to financial assistance members in time for Thanksgiving, and during December, the remaining supermarket and retailer gift cards were given to prepare for the Holidays.

YOUTH DEVELOPMENT

The Y is For Youth Development, because we believe that all youth deserve the opportunity to discover who they are and what they can achieve. That's why, through the Y, youth today are cultivating the values, skills and relationships that lead to positive behaviors, better health and educational achievement.



Because of generous contributions from donors, as well as funding through the American Rescue Plan Act (ARPA), in 2022 the Y served hot meals to Morrisville Pre-K Counts students for the first time.

Food Program 2022

YMCA of Bucks and Hunterdon Counties is the leading nonprofit child care provider in both counties. To be committed to youth development in our education and care programs means recognizing the serious issue childhood hunger presents to children in our community. Hungry children are challenged to focus, attend and enjoy learning, as well as other important social activities. Having fed vulnerable children in the Fairless Hills area for over a decade, in 2021, the Y moved towards a more comprehensive food program by becoming a USDA approved Summer Feeding Service Program (SFSP) sponsor.

As a working parent with many responsibilities, we feel that it is a blessing to be part of the food program. Making sure that our daughter has a healthy and nutritional breakfast and lunch is very important to us. Being part of this program has helped us to focus on her needs more.

At YMCA Camp Bucks at Cabrini (St. Francis Cabrini in Fairless Hills) the Y provided 4,300 meals to campers from June through August, 2022. U.S. Senator Bob Casey visited the camp to see our program in action first hand!

Y Camps

During the summer of 2022, 4,768 campers played, learned and made friends at 13 YMCA of Bucks and Hunterdon Counties camp locations.

The Y has partnered with Metro Esports in Doylestown to provide a gaming and technology learning experience through year-round programs and camps. At the heart of our work with youth in our communities is a commitment to build-up each individual by fostering camaraderie and teamwork in a safe environment that encourages skill development and healthy competition. Together with Metro Esports, the Y is broadening our impact and meeting youth on their playing field.



Metro Esports fostered friendships, skill development and fun for 167 campers during the first esports summer camp at the Doylestown branch.

Camp Carr Recovery from Hurricane Ida

September 1, 2021, Hurricane Ida tore through New Jersey, causing destruction from winds and flooding throughout Hunterdon County. In 2022, Y staff and volunteers recovered and revitalized Camp Carr in time for summer. Camp Carr families contributed to a recovery fund, which helped purchase two brand new yurts, a new camp perimeter fence, playground, and vital equipment lost in the storm. In June, Camp Carr welcomed more campers than it has in its history. In 2022, our Y served over 1,000 campers in Hunterdon County.



New Hope-Solebury Clubhouse for Kids

This past August, YMCA of Bucks and Hunterdon Counties purchased the New Hope-Solebury Clubhouse for Kids building and the 3.5 acre property, cementing our commitment to offer quality child care to the community for years to come. For over 30 years, the Clubhouse for Kids is one of the only center-based early childhood education providers in the area, providing children with outdoor nature experiences, and a celebrated kindness curriculum.



Without the YMCA, we never would have reopened following the pandemic lockdown in 2020. The Clubhouse for Kids is now fully enrolled with a growing waitlist, serving over 100 families including the school age child care program we provide at the New Hope-Solebury Lower Elementary School.

The Y is For Healthy Living, improving the community's health and well-being. The Y brings families closer together, encourages good health and fosters connections through fitness, sports, fun and shared interests. As a result, youth, adults and families are receiving support, guidance and resources needed to achieve greater health and well-being for their spirit, mind and body.

Between November 21 and January 8, 2023, YMCA of Bucks and Hunterdon Counties branches opened the doors wide to welcome our communities to try the Y for free. **5,220 individuals** who were not yet members visited our seven Y branches over 13,000 times during the Here For Our Community initiative to try Y pools, fitness centers, classes and Y Wellness 24/7.


